According to the Public Limited Company Act, article 13 of the Company's Articles of Association, the Company's directors to retire by rotation at the Annual General Meeting of Shareholders at the rate of one in third of the total number of directors. If the number of directors can't be divided into three parts, the number nearest to one-third must be issued. At this Annual General Meeting of Shareholders, there are three retiring directors. The Nomination and Remuneration Committee and the Board of Directors, excluding the Stakeholder Directors, has considered the qualifications of the nominated persons as follows: The Board of Directors has approved the appointment of two directors to be the directors for another term and has appointed another director to replace the directors who hold the position for 9 consecutive years.
